To All Cities and Agencies with Assessment Bonds and/or User Fees

Just another reminder that the time is almost here for the processing of the 2022-23 secured roll tax bills, which include taxes, assessments, fees, and charges.

To ensure that Proposition 218's provisions are being addressed by each agency using the county tax rolls for collection of taxes, assessments, fees, and charges other than the 1% ad valorem tax, we will require a certification resolution each year. The resolution certifies compliance with the proposition and includes a hold harmless and indemnification provision for administrative expenses of the County associated with collection of your agency's taxes, assessments, fees, and charges other than the 1% ad valorem tax. A sample copy of the required certification resolution is available on our website.

If you have already submitted the resolution, please disregard.

Please note that the county will not place any existing or additional taxes, assessments, fees, or charges on the tax roll without a certification resolution on file with our office.

The Assessment Bonds and/or User Fees and Certifications must be submitted to this office directly from the City or Agency no later than August 2, 2022.
